Thompson's emergency powers extended

The Grayville City Council unanimously approved to extend and renew Mayor Travis Thompson's emergency powers originally granted to him during a special meeting on Aug. 27 during Monday evening's regularly scheduled

The Grayville City Council adopted an ordinance establishing temporary executive powers to Mayor Travis Thompson pursuant to Illinois State Statute (65 ILCS 5/11-1-6 and 20 ILCS 3305/11) for the City of Grayville, in both White and Edwards Counties, which shall expire not later than the adjournment of the

first regular meeting after the state of emergency has been declared. The ordinance originally went into effect Aug. 27, and the City Council approved to extend it on Sept. 14. The next regularly scheduled meeting is scheduled for Sept. 28 at 7 p.m.

The board did discuss that White County had returned to the blue zone from the orange

zone, but the dates are not current on the Illinois Department of Public Health weekly statistics. IDPH's provisional metrics are currently being based off the week of Aug. 30 through Sept. 15. Edwards County has remained in the blue zone.

However, Mayor Thompson

EC Clocktower project tacks on \$23K to bill

The Edwards County Courthouse Clocktower restoration

added more than \$23,000 to its tab last week. On Tuesday, Sept. 8, the Edwards County Public Building Committee, an offshoot of the county's Board of Commis-

sioners, approved a change order for the project costing an additional \$23,618.90 to replace rotting wood within the structure. The project is being undertaken by Renaissance Roofing, and came with an initial price tag of \$700,000. Matt St. Ledger, Chairman

of the Committee, first presented a report on the progress of the project by Bob Yapp, a historical preservationist hired by the PBC to oversee the project.

"Everything seemed to be about where he thought it should be," said St. Ledger.

St, Ledger did inform the committee of an issue found by the Renaissance workers during the restoration pro-

"What they found is much more rotting wood than what they anticipated finding," he said. "They knew they were going to find some, but there

Gary Bisch home after COVID-19 hospitalization

After a nearly three week hospitalization, Grayville businessman Garv Bisch is back home recuperating from the effects of COVID-19. Gary was released from an Evansville hospital on the evening of Wednesday, Sept. 9. He had been hospitalized since Aug. 23. After returning home,

his daughter Tricia Myers of Grayville asked him, "So now that you've experienced the Coronavirus, do you feel that any of this has been overblown?" Gary replied, "All I know is you'd better be prepared. I wasn't, and I was ready to go kapoot! Give it up, baby!"

During his battle with COVID-19, Gary lost 23 pounds. He says he is still very weak and remains on oxygen at home. Gary added that the

virus wasn't the only thing he had to fight while hospitalized. "The loneliness - with nobody there – you just stare at the walls and listen to all the machines going off," Gary said. "But I thought to myself - I'm a bear - I will fight this!" Much of his battle against COVID-19 was waged in the Intensive Care Unit of the hospital where the only people he saw were doctors and nurses. Due to COVID-19 restrictions,

he could have no visitors.

"There were others there [with COVID] - you couldn't help but pray for those that had it a lot tougher than me," Gary said. "It's been the most horrible experience that I've ever had."

Gary and his wife Jean Ellen say they have no idea where he contracted the virus. Both say they have been careful with social distancing and

Semi crashes on I-64 near Grayville
