## Grayville water tower restoration project could hit over \$1 million price tag for city

During Grayville's Oct. 28 regular council meeting, the council listened to presentations from two different companies, Suez and Maguire Iron, concerning the restoration and rehabilitation of the water

Phil Knight, a water system consultant for Suez, presented first. Suez takes care of several water systems in the area but is part of an international corporation. Darin Clarke, a sales representative for Maguire Iron, presented second. Maguire Iron is an Illinois based company that also serves eastern Missouri.

The presentations offered by the two companies' representatives expressed that there are several renovations needed to restore the tower. Firstly, the representatives explained that due to large sections of paint and clear coating, both

inside and outside of the tower, peeling or chipping off that the entire tower would need a fresh coat of paint. This fresh coat of paint would require either company to strip or blast

## Illinois, Indiana Bridge Authorities make progress on Harmony Way Bridge plans

A plan for the future of the Harmony Way Bridge, or at least for how to get to that future, is beginning to take shape. In the first meeting between the

Illinois New Harmony Bridge Authority and the Indiana New Harmony Bridge and Wabash River Commission Thursday afternoon in Carmi, the two authorities began to discuss what dual ownership of the New Harmony Bridge would entail. Federal legislation allowing the White County Bridge Commission to transfer ownership of the bridge dictates that it must be given to both the Illinois and Indiana Authorities, or a

## ECSD. APD nab suspect after high speed chase

What began as a simple case of speeding quickly escalated into a high speed pursuit in both rural Edwards County and Albion

Sunday afternoon. Charles E. Dozier, 20, of Decatur, Ill. was taken into custody after leading an Edwards County Sheriff's Deputy and an Albion Police Officer on a high speed chase beginning at approximately 3 p.m. Sunday afternoon. Dozier racked up several charges during the

pursuit, including speeding, disobeying a traffic control device, reckless driving and aggravated fleeing and eluding. He was also charged with reckless conduct and obstructing a peace officer. Deputy Travis Roosevelt, while conducting

a routine traffic enforcement STEP patrol (a program funded through a grant from the Illinois Department of Transportation), clocked a vehicle southbound on Illinois Route 130 roughly a half mile from the West Salem crossroads traveling at a speed of 70 miles

per hour. Previously northbound on Route 130, Roosevelt turned around and attempted to initiate a traffic stop.

Rather than pull over, Dozier picked up
